Trunk or Treat Car Decorating Contest Official Rules

No Donation or Purchase Necessary to Enter or Win

- 1. Overview.** St. John's Lane Elementary School PTA, Inc. (the "PTA") is awarding three (3) gift cards to Glory Days Grill, each in the amount of twenty five dollars (\$25.00), for its decorating contest (the "Contest") for its first annual Trunk or Treat event. The Contest is sponsored by the PTA and begins at 3:00 p.m. Eastern Standard Time on October 29, 2022 and ends at 5:00 p.m. Eastern Standard Time on October 29, 2022 (the "Entry Period").
- 2. Eligibility.** The Contest is open only to individuals who are legal residents of the fifty (50) United States (including the District of Columbia) and are 18 years of age or older. No donation to or purchase of PTA membership or products is necessary to enter or win. A purchase does not increase an entrant's chance of winning. PTA Board members and the event Chair and/or the immediate family (spouse, parents, siblings and children) and household members (whether related or not) of each such employee, are not eligible. All U.S., federal, state and local laws and regulations apply.

- 4. Agreement to Official Rules.** Participation in the Contest constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding. Winning a prize is contingent upon fulfilling all requirements set forth herein.
- 5. Entry.** To enter Contest, entrants must decorate their vehicle at any time on the day of the event prior to the Entry Period. The Contest is limited to one entry per family.
- 6. Judging.** There will be three winners. At the conclusion of the Entry Period, the winners will be selected by popular vote of attendees based on personal subjective determination. The Contest is limited to one (1) prize per household.
- 7. Prizes.** Each of the three Prizes is one (1) twenty five dollar (\$25.00) gift card to Glory Days Grill (see www.glorydaysgrill.com). Winners are liable for any and all taxes relating to their prize.
- 8. General Conditions.** All federal, state and local laws apply. As a condition of entry, and by participating in and entering the Contest, you agree to be bound by these Official Rules and the decisions of the PTA, which shall be final and binding in all respects, and to release,

discharge and hold harmless the PTA, its parents, subsidiaries, affiliates, agencies, agents and representatives from any and all claims, charges, injuries, liability, losses and/or damages of any kind caused by, resulting from or arising out of your participation in the Contest and/or your acceptance, use, misuse, loss or misdirection of a prize. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Official Rules will otherwise remain in effect and will be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. If the Contest is not capable of running as planned for any reason, the PTA reserves the right, in its sole discretion, to cancel, modify or suspend the Contest.

9. **Disputes, Governing Law.** Except where prohibited, as a condition of participating in this Contest, you agree that any and all disputes that cannot be resolved between the participant and the PTA, claims and causes of action arising out of or connected with this Contest, or the prize awarded, or the determination of the winner must be resolved individually, without resort to any form of class action. Further, in any such dispute, under no circumstances will you be permitted or entitled to obtain awards for punitive, indirect, incidental or consequential damages, or any other damages, including attorneys' fees, other than participant's actual out-of-pocket expenses (if any), not to exceed twenty dollars (USD\$20). This Contest and any dispute arising under or related thereto (whether for breach of contract, tortious conduct or otherwise) will be governed by the internal laws of the State of Maryland, without giving effect to its conflicts of law or choice of law principles. Any legal actions, suits or proceedings related to this Contest (whether for breach of contract, tortious conduct or otherwise) will be brought exclusively in the state or federal courts located in the State of Maryland, and each participant accepts and submits to the personal jurisdiction of those courts with respect to any legal actions, suits or proceedings arising out of or related to this Contest.
